Please note that VSG rule 16.3 states that:

• no member shall be eligible to be elected as a member of the Committee unless such member has been a financial member of the Guild for at least twelve (12) months prior to the date of the Annual General Meeting in the year he/she seeks election.

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to <u>IEBnominations@aec.gov.au</u>. The **subject line** of your email should include the reference **"E2025/30 – VSG - Your Name"**.

- 2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
